Reduce Energy Usage During Peak Hours

Peak hours are the busiest time for RVEC, since many member-owners are using electricity at the same time. It also costs RVEC more to buy electricity when the demand is high during these peak times, and the cost of your future electricity may also rise. Using less electricity during peak periods of time saves money.

Here's what you can do to help us help you during peak hours. These hours are usually during the hottest summer days between 11 a.m. and 8 p.m.

- Shift household chores and activities away from peak periods.For example, wait to run your dishwasher until you go to bed at nights.
- Use the most energyefficient appliances you have. Your microwave uses considerably less energy than your stove or cook top range. 19.04.02
- If you're buying a new appliance, make sure you purchase a highly efficient appliance. Look for "Energy Star" labels when you're evaluating.
- Be aware of your energy consumption, and try to get in the habit of using energy efficiently all year!



CEO CommentsEnergy Bill Provides Affordability

RVEC applauds our state legislators who voted for passage of Senate File 2311, an energy bill that has several sections beneficial to member-owners of lowa's electric cooperatives, especially regarding affordability. Further, we want to applaud Governor Reynolds for signing the bill into law.

This bill provides much-needed regulatory parity and clarity for electric cooperatives. With a business model grounded in local control and governance,

we are in business solely to serve you – our member-owners.

The energy efficiency sections of SF 2311 attracted a great deal attention. Nothing in this bill changes the requirement that RVEC will offer energy efficiency programs. As part of these offerings, the bill will ensure these programs are cost-effective – meaning that you will not foot the bill for a program that is not financially responsible. The legislation also eliminates time-consuming and duplicative reporting to the lowa Utilities Board, which will save our employees valuable time and resources that could be directed into further serving you.

Providing robust energy efficiency programs and services has long been the foundation of our commitment to environmental stewardship, even before there was a mandate to do so. The bill signed into law by Governor Reynolds does nothing to change our commitment to energy efficiency.

The energy landscape has dramatically changed in the past 30 years, leading to more federal

rules, regulations and mandates. When there are comprehensive federal policies in place, additional state mandates quickly become duplicative and unnecessary. This bill will require the lowa Utilities Board to consider existing federal regulations before establishing similar state mandates. Again, this is beneficial for keeping your cooperative's business operations efficient and costeffective.

Our dedication to the environment doesn't stop with energy efficiency. Through sensible investments in renewable energy like Community Solar and innovations in technology like Automated Meter Infrastructure, we continue to seek modern ways to deliver reliable, affordable and responsible electric service to our member-owners.

Beware of Phantom Loads in Your Home

You may turn off the TV, hang up the cordless phone, let your computer go to "sleep" and power down your DVD player, but all these appliances – and many others – continue to draw electricity, costing you energy dollars.

Energy use is multiplied in any appliance that has a lit display clock, memory chip, or remote control. These include TVs, DVD and CD players, cable and satellite boxes, cordless phones, microwaves, water coolers, video game players, burglar alarms and much more.

According to the Department of Energy, 40 percent of all electricity used to power home appliances is consumed when the appliances are turned off. It's also estimated that these energy "vampires" use 5 percent of our total electricity and cost U.S. consumers more than \$3 billion annually, according to the Alliance to Save Energy.

So what can you do to save money? 14.27.01

- Look for the Energy Star label on all appliances that you purchase.
 Energy Star appliances may use as much as 50 percent less than other appliances.
- Purchase appliances such as computer and monitors that will go into sleep (also called power management or stand-by mode) when not in use.
- Anytime you purchase an appliance (such as a microwave) with a continually lighted display and/or clock, you will pay for the constant-on feature. If you can live without these features, your energy costs will decrease.
- If you keep items in your entertainment center powered through power strips, you can turn off – and back on – all the equipment at once.

Fairgoers may register to win one of three Instant Pot Ultra 10 In 1 Multi-Use Programmable Cookers from Touchstone Energy Cooperatives of Iowa. The Instant Pot is the next generation in kitchen appliances. It combines a pressure cooker, slow cooker, rice/porridge cooker, cake maker, yogurt maker, sauté/searing function, steamer, warmer and sterilizer along with custom programming for pressure and non-pressure cooking. Favorite dishes can be made and ready up to 70 percent faster.

Three winners of the Instant Pot will be chosen, at random, following the close of the fair. Additional energy efficiency and savings information will be displayed in the booth.

Cooperative member-owners have a voice in how cooperatives are run, making sure their coops enhance quality of life by providing affordable electricity. Co-ops encourage member-owners to save money through responsible energy use and offer discounts on qualified products and services member-owners use every day.

Vacation Usage: Your Meter Doesn't Stop While You're Away

Vacation season is upon us and everyone will be traveling to see the sites and sounds of our great country. And while you are gone for a couple of days or weeks, your electric bill will surely go down, right? Wrong.

A lot of people believe when they are gone their electric consumption decreases or even stops. When in actuality, most electric appliances are still running unless you have taken measures to shut them off. Here are some questions that you need to ask yourself to see if your electric bill is really going to go down.

- Did you shut off your electric water heater? If not, the water heater will still run in order to maintain the temperature that you have the thermostat set at.
- Were the refrigerator and freezers emptied and turned off?
 Otherwise, the refrigerator and freezer will continue to run.
- Did you shut off your clocks, computers, dehumidifiers, air conditioner, lights, TVs, power ventilators and attic fans? Some of these items seem small, but everything adds up. 22.23.01

Business & Commercial Loan Programs

RVEC takes an active role in the development of rural lowa. We provide leadership and financial participation in economic and community development. In 1996, the RVEC Board of Directors established a Revolving Loan Fund to provide a local resource for low-interest loans to area businesses.

RVEC uses a unique USDA program, the Rural Economic Development Grant & Loan program, that allows up to \$360,000 at 0% interest financing to assist a non-profit organizations with a community development project. When the loan is re-paid, all the money stays with RVEC, allowing us to provide low-interest loans to additional qualifying business and community projects.

This is a great way for RVEC to demonstrate concern for community, one of the seven cooperative principles. The RVEC Revolving Loan Fund has assisted more than twenty projects since 1996. As a member, you can be proud of our efforts together to invest in the long-term improvement of the area's rural economy.
