Alternate Energy Production Facility Notice Requirement

On January 1, 2013, a notification requirement went into effect. This requirement applies to the owner of an alternate energy production facility which will be attached to an electric transmission or distribution line. Alternate energy production facilities are defined as solar, wind turbine, waste management, resource recovery, refuse-derived fuel, agricultural crops or residues, or wood burning facilities used to generate electricity.

Under this requirement, the owner of the facility is required to provide written notification to their utility of the intent to construct or install the facility at least 30 days prior to construction. In the written notice the owner must provide information on the type of facility and the anticipated completion date of the construction. 12.27.01









Bus-Stop Safety Reminders

CEO Comments —

We know your satisfaction with RVEC is directly related to the reliability and affordability of the services we provide. Maintaining reliability is not something that happens by chance. Throughout the year, our distribution infrastructure is subject to many risks. On any given day, ice storms, high winds, tornadoes, squirrels and birds, and even errant drivers, can interrupt electric service and cause a power outage.

We are constantly preparing for the things we can control on our system, such as planned and routine maintenance outages, and for unexpected outages that are often beyond our control. We set high goals for the reliability and accessibility of the power we provide to you. We balance the building and maintenance of

your system, including proper emergency back-feed capabilities that allow for shorter outage periods, with our need to satisfy your requirement to control costs.

Your board of directors and co-op staff recently filed RVEC's Annual Reliability Report with the lowa Utilities Board for the 2020 calendar year. Maintaining a reliable system takes hundreds of hours of planning, maintenance, inspections and system upgrades. Equally important is our commitment to balancing reliability and affordability with member-owners' expectations, which requires a mindset of continuous improvement and looking ahead to anticipate your future needs.

The Reliability Report is designed to show past performance by reporting on a number of core reliability measures. We use these data points to come up with an Average Service Availability Index (ASAI) – a reliability index commonly used by electric power utilities throughout the U.S. 28.32.01

We are pleased to report that RVEC's overall reliability rate in 2020 was 99.9918 percent. This "four-9's of reliability" is the slightly down from last year's number of 99.9925 percent. The goal for most utilities is "five-9's". We were much more fortunate than our neighbors to the East, who suffered significant damage from the August derecho. What was major-event elsewhere only caused a few dozen outages on our system that were repaired the same day. Of course, the derecho had a sever negative impact on their availability index.

RVEC's reliability is a testament to the leadership of the board and daily attention to detail in construction and the safe, timely restoration of outages by RVEC employees.

Why Membership Matters

You could be a member of a lot of different places; a gym, a 4-H club, a food of the month club – the list goes on and on! But what makes being a member of a co-op different? The simple answer to that question is that when you are a member of a co-op, you are also an owner.

Whatever your summertime projects may be – putting in a fence, planting a tree, or starting a garden - call 811 or file your locate requests online. lowa One Call is here to help!

Things To Remember

- ✓ You must contact lowa One Call at least 48 hours (not including weekends) and holidays) in advance of your plans to excavate.
- ✓ A ticket is valid for 20 calendar days from the time of the call.
- ✓ ALWAYS check yard markings and Iowa One Call Positive Response ticket status before beginning excavation.

What Does NOT Get Marked

Only the buried facilities registered with lowa One Call will be located and marked. Private facilities will not be marked for locates. These can include LP gas lines, sprinkler systems, gas grill lines, or more.

Homeowners may call private locating companies to have their private facilities marked.

Tolerance Zone

Paint and flag markings are approximate. The tolerance zone is 18" on either side of the markings. You should hand dig with caution in the tolerance zone to expose the facility.

Paint or Flag Color Indicators

Underground facilities will be marked according to the APWA Color Code. It is extremely helpful for you to outline your proposed excavation site in white paint or with white flags to reduce any confusion as to where the proposed excavation will occur.

- Red Electric Power Lines, Cables, Conduit and Lighting Cables
- Yellow Gas, Oil, Steam, Petroleum or Gaseous Materials
- Orange Communication, Alarm or Signal Lines, Cables or Conduit
- ❖ Blue Water, Irrigation and Slurry Lines 35.08.01
- Green Sewers and Drain Lines
- Pink Temporary Survey Markings
- White Proposed Excavation
- Purple Reclaimed Water

Before Contacting Iowa One Call

- When you contact lowa One Call with a locate request, a series of questions will be asked.
- What is your name, address and phone number?
- What type of work will you be doing? (i.e. planting a tree, installation of fence)
- What is the dig location's address, city, county and nearest intersecting street?
- At the dig location, where will you be digging? (i.e. east side of house, within 5 ft radius of white stake.)
- When will you be digging? (i.e. 3 days, next week)

Before Iowa One Call arrives, it is extremely helpful for you to outline your proposed excavation site in white paint or with white flags to reduce any confusion as to where the proposed excavation will occur.

Spot Your Number

Read Watts Current and watch for your location number. If you spot it, call RVEC by the 20th of the month and you will receive an electrical bill credit for \$25.00.
